

§ 1 General

1. The Website is operated by PMA FURNITURE Sp. z o. o. (a limited liability company) based in Poland, 62-070 Konarzewo, Mlynska 47, KRS number 0001014208, thereafter referred to as PMAF or Administrator.
2. PMAF is the administrator for personal data collected when using the website in accordance with the General Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data („GDPR”).
3. The website offers functionality for both unregistered users (limited functionality) and registered users (full functionality). Each time the rule book refers to a ‘user’ without any further specification, this will mean both an unregistered user as well as a registered user.
4. Information presented on this website does not constitute an offer and is solely intended as a guideline and to encourage the submission of a request for offer.
5. For the purpose of clarification, no statement on this Website shall be deemed as forming a basis for any commercial contract.
6. All content of this website is copyright and owned by PMAF or their partners.
7. A user may utilise any copyright material only with prior written consent from PMAF.
8. The use of this website is free of charge.
9. The use of this website implies the acceptance of the provisions of this rule book.

§ 2 Unregistered user

1. Any unregistered user may view the generally accessible content of this Website without logging in.

§ 3 Registered user

1. A registered user may view the full content of this website. Viewing the restricted areas may require logging in.
